Fairchild Creek

Fairchild Creek is a major tributary of the Grand River. The 401 square km Fairchild watershed originates in the Beverly Swamp (Puslinch Township). Eastward it reaches to Rockton and Lynden, westward into Brantford, and south to Onondaga. The creek itself is divided into countless tributaries. In the north there is significant recharge from ground water and wetlands with some brown trout habitat. Farther south in the clay soils the creek slows and warms.

About 20 percent of the watershed has forest cover. Problems in the watershed are urban runoff, erosion on the clay soils, and nutrient loading from agriculture and sewage treatment. Annual flow averages 3.6 cubic metres/second.
